Decision regarding relaxation of age bar for direct recruitment of non-academic staff in the light of the judgement of Hon'ble High Court of HP.

The Board deliberated the issue at length and resolved that since the BOG is not competent to relax the age bar, as the competent authority in this regard is NIT Council. Therefore, the matter may be referred to NIT Council to take appropriate decision. However, in the meantime the candidate may be given chance to appear in the recruitment process and the results may be declared as per the final decision of Hon'ble Court in

the matter. BOG also desired that Hon'ble Court may be apprised of the fact that power of relaxation of age is vested with the NIT Council only which may take time more than 6 weeks.
