2.	Entry of HP residents into District Hamirpur from other States of India except mentioned in Sr. No. 1 by any mode of Transport (Air/Rail/Road).	Home Quarantine	14 Days
3.	Person going from District Hamirpur across Inter-State border for medical, business or office, purposes and returning within 48 hours.	NA	NA
5.	Persons going from District Hamirpur across Inter-State border for Medical, Business or office purposes and returning after 48 hours.	Home Quarantine	14 Days
6.	Persons coming from abroad who have been put in Quarantine outside the State	Home Quarantine	14 Days
7.	Persons found violating Home Quarantine	Institutional Quarantine	14 Days
8.	Labour brought from other States by Orchardists/Agriculturists/ Contractors/ Project Proponents	Quarantine facility arranged by concerned Orchardists/Agriculturists/ Contractors/ Project Proponents	14 Days
9.	Any Person who is required to be put under Quarantine as per above categories but does not have separate room in his Home for Quarantine.	Institutional Quarantine	14 Days

11.	In cases where person carries a personal COVID negative test report issued by a lab authorized by ICMR within last 3 days prior to date of journey.	Home Quarantine	14 Days

However, in exceptional cases Institutional Quarantine requirements may be relaxed on recommendations of BMO/ Medical Board.

Any person who is required to be put in Institutional Quarantine may opt to stay in a paid Quarantine facility at his own cost in the Hotels identified by the Sub-Divisional Magistrate.

Any violation, obstruction, resistance, negligence or refusal by any person to comply with the directions as aforesaid shall render such person liable to prosecution under Sections 269,270 of IPC and Section 51 of the Disaster Management Act 2005;

This order shall come into force with immediate effect.
