SCOPE OF WORK:

For engagement of eligible Actuary or Firm for carrying out actuarial valuation of the Institute Employees as per AS-15 (Employee Benefits) disclosing the same in annual accounts of the Institute for the F.Y 2023-24.

- > Pension Liability for pensionable and existing staff (As per CCS Pension Rules)
- > Gratuity Liability for GPF (As per CCS Pension cum Gratuity Rules)
- Gratuity liability for NPS members (As per Payment of Gratuity Act as applicable to Central Government / Autonomous employees)
- > Leave encashment liability (As per CCS Leave Rules)
- Actuarial Valuation for Employees' Retirement Benefit as on 31.03.2024
- > Retirement benefits viz, Pension, Communication of Pension, Leave Encashment and Gratuity.
- > Any other point to be considered as per AS-15(Employee Benefits)

To determine the actuarial liability of the NIT Hamirpur of approx. 350 serving permanent Staff (including Faculty & non-teaching staff) and approximate 163(159+4) nos. of pensioners as on 31-03-2024. The age of superannuation of 60 years for all Non-Faculty employees (ministerial and technical) and for Faculty Staff, the age of superannuation is 65 years.

Eligibility Criteria:

- The Actuary should be a practicing fellow member of the Institute of Actuaries of India for at least preceding three years. In the case of firms it should be registered with the Institute of Actuaries of India and should have relevant experience of at least three years. Authenticated self-attested copies to be submitted.
- The Actuary/Firm must have done at least 03(Three) actuarial valuation for Central Government/Autonomous Body/ Ministries/Departments/Educational Institutions in the last three years.

Terms and Conditions:

- > The following documents (self-attested) are required to be submitted along with offer document in the format as per annexure-I
 - 1. Goods & Service Tax Registration as well as PAN No. (Firm or Individual)
 - 2. Copy of Membership Certificate issued from the Institute of Actuaries of India/Firm registration certificate from the Institute of Actuaries' of India

- > No TA/DA or out of pocket expenses will be admissible to attend any meeting, Submission of offer or during completion of job.
- Appointment of actuary will be for the valuation of Pension, Commuted Pension, Gratuity (including NPS members) and Leave encashment as per AS-15(Employee Benefits)
- > The interested Actuary/Firm have to submit their offer strictly in the Pro-forma along with relevant documents in support.
- > No request for extension in the date of submission of offer will be considered.
- NIT Hamirpur(H.P) will not consider any request for increase in the price quoted by Actuary/Firm for the defined job.
- No overwriting, corrections and cutting is permitted.
- > Offers received not as per prescribed form will be summarily rejected.
- > Unsealed or unsigned offers will be summarily rejected.
- > The work should be completed within 3 weeks from date of issue of award
- The Actuary/Firm will be responsible to clarify/explain the details of Reports/Certificates to the Internal Auditor/CAG and to the Finance Committee/BOG of the Institute, if required.

Payment Terms:

The payment for the work will be released after acceptance of the valuation Reports/Certificates by the Competent Authority. No interest shall be paid for delayed payment.

Appointment period:

The appointment of the actuary / actuary firm for the above mentioned scope of work will be for a period of one year. However, the same can be extended upto three years on annual basis subject to satisfactory performance and recommendation of the Deputy Registrar(Finance & Accounts) of the Institute.
