All the eligible students are advised to apply online as per guidelines/eligibility criteria given on the portals and adhere to the timeline for applying. The applicants are advised to follow the following process for applying online:

1. Create User Name on the portal (if applying fresh).

2. Apply on the portal and upload the desired documents (must be scanned from original ones).

- 3. Valid Income Certificate of current financial year (i.e. from April, 2024 onwards) must be issued in the name of parents only by the competent authority as prescribed by scholarship providing agency/ministries.
- 4. The Nationalized Bank Account seeded with AADHAR must be in the name of students. Jan Dhan Account is not acceptable.

5. eKYC is mandatory for Fresh and Renewal Scholarships on the National Scholarship Portal (NSP) through NSP OTR.

- 6. The print-out of application along with self-attested documents in support of details filled in the online application must be submitted in the office of the undersigned immediately after submission of online application, failing which the application will not be verified online by Institute.
- 7. The applicants must check their status frequently to remove the objections raised by verifiers, if any.

All the students are advised to check the Institute Website/other scholarship websites/ Portals and Notice Boards on prominent places regularly for Notices issued by this office from time to time regarding scholarships & other student welfare matters.
