1. Scope of Work

NIT Hamirpur invites expression of Interest in prescribed format as annexure 1 for scrapping of three vehicles (Bus no. HP67-1315, Bus No. HP 67-1316 & Bus No. HP67-7588) at Registered Vehicle Scrapping Facility (RVSF) of GOI / State Govt with following items under its scope of work

- 1) Transportation of three vehicles from NIT Hamirpur to RVSF facility.
- 2) Scrapping of three vehicles as per scraping guidelines published on 23rd September 2021 through Gazetteer of India (Annexure 1).
- 3) Registered Vehicle Scrapping Facility shall facilitate the process of submission of request electronically and transmission of registration certificate (defaced or punched) to road transport or regional transport office in getting vehicle deregistered as per provisions of the Act.
- 4) Issuance of certificate of deposit to NIT Hamirpur
- 5) Issuance of certificate of vehicle scrapping to NIT Hamirpur.
- 2 <u>Eligibility Condition</u>: Any establishment which holds a Registration for Vehicle Scrapping issued under these rules for carrying out dismantling and scrapping operations. Copy of registration in format 1A (as per Gazette of India notification dated 23/09/2021) must be enclosed with EOI. Non enclosure of this document shall be a sufficient ground for automatic rejection of EOI.

3. Submission of Expression Of Interest:

- i) All the prospective bidders with registered vehicle facility shall send the Expression of interest latest by $\ \, dated \ \,$
- ii) Bidders are expected to visit the premises of NIT Hamirpur for inspecting the three vehicles which will further enable them to quote rationally for scrapped values of these vehicles.
- iii) Expression of Interest received after due date will not be accepted and automatically stand rejected.
- iv) All the pages enclosed with expression of interest must be signed by bidders.
- v) Bidders must submit the following signed documents for further evaluation of EOI
 - a) Application form as per attached format.
 - b) Price Bid as per attached format.

- c) EMD of desired amount.
- d) Signed copy of EOI & its Annexures
- e) Copy of Registration (Form 1A) as registered vehicle scrapping facility.

4. **Earnest Money Deposit (EMD) / Security Deposit**. All the bidders must submit the EMD amounting Rs. 20000.00 in form of Banker Cheaque / DD/ FDR issued in favour of Director NIT Hamirpur. EMD of unsuccessful bidders shall be refunded not later than thirty days after issue of award for scrapping of vehicles.

In case of successful bidder, EMD shall be treated as security and shall be released after receipt of certificate of vehicle scrapping from registered vehicle scrapping facility / bidder.

5. General Terms & Conditions.

- i) Before submitting the EOI, Bidders are expected to physically inspect the vehicles at NIT Hamirpur to quote rationally.
- ii) Successful bidder shall be fully responsible for transportation of all above mentioned vehicles from NIT Hamirpur to their registered vehicle scrapping facility.
- iii) In price bid, bidders must quote the transportation charges if any from NIT Hamirpur to RVSF along with price quoted for vehicles.
- iv) Evaluation of responsive bidders shall be on basis of maximum financial value received by NIT Hamirpur after deduction of transportation charges of these vehicles if any.
- v) Successful bidder shall deposit the financial cost agreed in EOI after deducting the transportation charges within fifteen days after issue of award letter for scrapping of vehicles.
- vi) Above mentioned vehicles shall be handed over to successful bidders after receipt of agreed financial cost. After handing over vehicles at NIT Hamirpur, Institute shall not be responsible for any issue / matter arises after handing over vehicles.
- vii) Bidder shall provide certificate of deposit to NIT Hamirpur after receipt of vehicles.
- viii) Bidder shall provide the certificate of vehicle scrapping to NIT Hamirpur within three months of issue of award letter.
- **ix)** After receipt of certificate of vehicle scrapping, security of successful bidder shall be released within fifteen days.
- The whole process shall be smoothly linked with VAHAN by successful bidder and on pan India basis irrespective of the location of any vehicle registering authority.

- xi) The bidder shall facilitate the process of submission of request electronically and transmission of registration certificate (defaced or punched) to road transport or regional transport office in getting vehicle deregistered as per provisions of the Act.
- **xii)** The bidder shall ensure that removal or re-cycling or disposal of hazardous parts of the scrapped vehicle is done as per CPCB guidelines for Environmentally Sound Management of End-of-Live Vehicles and AIS-129.

6. Dispute Redressal & Application of Law

Right of acceptance or rejection of any EOI or all EOI is reserved with Director, NIT Hamirpur. Further for any doubts or interpretation of clauses, decision of Director NIT Hamirpur shall be final and binding on bidders. In case of any dispute, Jurisdiction of District Court Hamirpur shall apply.
