**Subject: Information for M.Tech./M.Arch. Students Admitted Through CCMT-2021 and M.Sc. Students Admitted Through CCMN-2021 (Odd Semester, Academic Year 2021-22)**

In view of prevailing COVID-19 pandemic situation, following are the guidelines/directions for the information of M.Tech./M.Arch./M.Sc. students admitted through CCMT-2021/CCMN-2021:

1. The admission of the M.Tech./M.Arch./M.Sc. students through CCMT-2021/CCMN-2021 are provisional and shall be considered as confirmed only after successful completion of documents verification at the time of Physical reporting of the students in the Institute. The dates for Physical reporting of students shall be announced on the Institute website at appropriate time. Till then, the students need not report to Institute in-person for registration or to attend the classes. Both the Registration process and the conduct of classes shall be via online mode, till further orders.
2. As per the schedule of CCMT/CCMN-2021, the admission process is still going on (tentatively till August end). The students, whose names are finalized by CCMT/CCMN-2021 for admission to NIT Hamirpur, shall register on the Institute's website ([www.nith.ac.in](http://www.nith.ac.in)) w.e.f. 19/08/2021.
3. The classes will commence from 23.08.2021 through online mode (Google Meet) for those students who shall complete their online registration process. The User id shall be the Institute Email id for the purpose of attending the classes. The students are required to contact the respective HOD/ Registration Incharges for knowing their Institute email id and Roll No.
4. The eligible students of M.Tech./M.Arch. programmes shall be paid arrears of their stipend upon confirmation of their admission by the Institute after physical verification of required documents in the Institute.
5. The students are required to download the Registration Form and fill all the details (Except Roll No.). The sample Form prepared by the Department concerned should be referred to while filling the details. It shall be the sole responsibility of the student to fill the information legibly and correctly. For any discrepancy, the student concerned shall be responsible.
6. Filled and signed copy of the Course Registration Form in pdf format should be uploaded by the student (on or before 06.09.2021) through the link provided at Institute Website after entering the required details. For any further query, students may contact the Registration Incharge of the Department concerned.
7. The Self attested hard copy of the documents, as per the enclosed Check List & Undertaking, is required to be submitted by the students via post to the concerned Head of the Department by 15/09/2021 failing which their registration may be cancelled.
