ORDER UNDER SECTION 33 OF THE DISASTER MANAGEMENT ACT- 2005

WHEREAS a sudden spike in the cases of COVID-19 has been observed in past few days which poses a dire need to take emergency measures to curtail the spread of COVID-19 in the District.

AND WHEREAS, after a careful review of the recent spike in COVID-19 cases it has been observed many of these cases have been reported from cultural/ religious/ social gatherings.

NOW, therefore after considering the current situation of COVID-19 pandemic and overall circumstances I, Debasweta Banik (IAS), District Magistrate, Hamirpur (Himachal Pradesh) in exercise of the powers conferred in me under section 33 of the Disaster Management Act-2005 and in public interest at large do hereby order and direct that

- All shops shall remain open only between 6:00AM to 6:00PM daily except Medical/Chemist shops, Hotels/Restaurants and Dhabas.
- All Hotels/Restaurants / Dhabas/Eateries shall be permitted to operate only upto 10:00PM at night. The Dhabas on national highways /other important roads catering to buses in transit/ goods carriages essential items shall be exempted from this requirement.
- 3. Hotels/Restaurants/Dhabas/Eateries would be allowed to operate only for take away food and home delivery services. No eating & dining service would be permitted within the establishment. This condition shall not be applicable on the Dhabas on National highways /other important roads catering to buses in transits / goods carrying essential items. No on the spot eating shall be allowed at Rehri's/kiosks/roadside stalls as well and only take away service would be permitted.
- CMO will ensure that weekly testing of COVID-19 of staff working in Salons/Barber Shops/ Hotels/Restaurants/Dhabas/ Eateries be done.
- 5. All the persons coming from outside the state especially from high load cities are advised to inform local Panchayats/ Heath staff/ SDMs. CMO shall ensure random sampling amongst these returnees. These should consist of at least 25% of the sampling being done daily.

- 6. RTO Hamirpur shall compile list of all contact carriage permissions given for travelling outside the state indicating the duration of permits and submit report along with detail of these bus operators to the DEOC Hamirpur daily on mail id ddmahamirpur@gmail.com.
- 7. All BDOs are directed to get the attached questionnaire filled by Pradhans of Gram Panchayats in their block on a weekly basis. All Pradhans are directed to submit filled up—questionnaire to the concern BDOs every Monday positively. BDOs shall be responsible for transmission of the relevant data share by the Pradhans with concerned departments immediately.

THIS order shall come into force with effect from 22th April 2021.
