- (i) In case selected candidate fails to join within due date, then his/ her seat shall stand cancelled and seat may be offered to the candidate from the Waiting List, as per merit, if any.
- (ii) The Head of the Architecture Department shall, in time bound manner, issue the Letters to the above selected candidates informing them about their selection and other necessary information .
- (iii) The Head of the Architecture Department shall ensure physical verification of the Original Documents of the selected candidates before their joining the Ph.D. Programme in the Department and the complete Personal Files, with attested copy of all relevant documents placed in sequence, of all the PhD Research Scholars joining the Institute is required to be forwarded to the Office of Dean(Academic), by the concerned HOD, on or before **14/07/2023**.
- (iv) The Head of the Architecture Department shall allocate the Registration Numbers to the selected candidates in continuation to the last Registration Number allocated during January 2023. For example, if in Civil Engineering Department the last Registration No. allocated to a PhD Research Scholar was 23RCE002 then the registration no. to the selected candidates of June 2023 shall begin with 23RCE003 and so on.
- (v) At this stage, the allocation of main Supervisor only is approved. The addition of Co-Supervisor, if required, may be approved at later stage in accordance with Clause 8.1 of the Ordinances for Doctoral Programmes.
- (vi) In addition the document considered by DSSC of Department of Physics & Photonics Science in their meeting held on 23-06-2023 for the applicant Mr. Maheshwar Singh was considered & it was not found in order. Hence, the case is not recommended.
