1. The Ph.D./PG (2<sup>nd</sup> year) students (both hostelers and non-hostelers who have already submitted their Application-cum-Undertaking in response to the Notification No. NITH/Acad/M/2020/29906-25 dated 22/09/2020) carrying out research work for thesis/dissertation and who wants to mandatorily conduct experimental/practical/lab/computational work in the campus should obtain prior permission in this regard, over email, from the HOD concerned (through Supervisor(s)).
2. The HOD concerned shall further forward the information about those Ph.D./PG (2<sup>nd</sup> year) students who stay in the Hostels and have been permitted by him/her for conducting experimental/practical/lab/computational work in the Institute Labs, to the Office of Dean (Student Welfare) by 20/10/2020.
3. Dean (Student Welfare) shall decide and notify the schedule for reporting of Hosteler students to the campus.
