

Notice

All boarders of NIT Hostels are hereby directed to adhere to following decisions taken in best interest of all:

1. **Anti-ragging regarding:** All students are directed to go through the anti-ragging guidelines attached with this notice and comply with these guidelines with utmost sincerity. Strict and prompt action shall be taken against any student or group of students for violation of any provision mentioned in anti-ragging guidelines. Further students are advised and directed to first resort to mechanism as mentioned in anti-ragging guidelines for reporting any incident of ragging or any other associated issue.
2. **COVID protocol:** As the threat of COVID infection is still not over completely and hence all boarders are advised to strictly follow COVID appropriate behaviors i.e. use of mask properly.
3. **Vehicle Parking:** Students to whom the vehicle permission is given by competent authority are directed to park their vehicle near open air theater only. Any violation in this connection will lead to withdrawal of permission immediately.
4. **Roaming in Residential areas of Faculty and Staff :** It has been observed that students are roaming and sitting in residential areas of faculty and staff which is out of bound to students and hence all the boarders are advised and directed to avoid roaming and sitting in these residential areas.
5. **Judicious use of water:** Due to irregular supply of water from main source i.e. Beas river, all the boarders are advised to kindly use the water judiciously so as to avoid any wastage of water. Further kindly ensure to switch off the tap after each use.
