

## OFFICE ORDER

Foreign travel for attending conferences shall be strictly limited to the period of conference and shall be entertained during vacation period ensuring teaching is not affected.	as given under:- Outside the Institution/Foreign travel for attending conference or other CPDA activities to be undertaken preferably during vacation period only, however, short duration visit with period up to maximum of 5 days may be allowed every year during running semester for each block period subject to the condition that proper teaching load arrangements be provided.
		Leave shall be granted as per Institute norms only.

The total expenditure towards all items under category A such as TA/DA, registration fees, visa fees for participating in National / International conferences / workshops/ symposia and visits for research interactions shall be up to maximum of 70 % of the CPDA (i.e. Rs. 2.1 Lakh) for three year period. The total expenditure towards all items under category A such as TA/DA, registration fees, visa fees for participating in National / International conferences / workshops/ symposia and visits for research interactions shall be up to maximum of 70 % of the CPDA (i.e. Rs. 2.1 Lakh) for three year period  However if expenditure for attending International conferences, research collaboration visits abroad exceeds the balance CPDA fund available in a FY, a notional sanction of the same may be furnished in the present financial year. However reimbursement for the expenditure which is in excess of CPDA fund available shall be made after faculty member become eligible for the excess CPDA fund in next year. This will ensure the participation of faculty members in quality conference / research interactions in international conferences in the early part of block period.
8	All regular faculty members who have cleared their probation period shall be eligible for the grant. If a faculty member joins the institute or retires from the institute services / leaves the institute (resignation or deputation) or any other reason) in between a block period, the faculty member shall be entitled for this allowance on pro-rata basis.	All regular faculty members appointed in regular scale on probation <i>I</i> contract basis shall be eligible for the grant (as amended in 11 <sup>th</sup> meeting of council of NIT, held on 18/07/2018). If a faculty member joins the institute or retires from the institute services <i>I</i> leaves the institute (resignation or deputation) or any other reason) in between a block period, the faculty member shall be entitled for this allowance on pro-rata basis.
