The guidelines regarding Physical Reporting and 1st Semester Registration for the M.Tech./M.Arch./M.Sc. students admitted through CCMT-2022/CCMN-2022 and MBA students are as under:

1. The admissions of the M.Tech./M.Arch./M.Sc./MBA students are provisional and shall be considered as confirmed only after successful completion of documents verification at the time of Physical reporting of the students in the Institute during the period from 17/08/2022 to 19/08/2022.
2. For 1st Semester registration, the students are required to physically report to the Institute and submit the duly filled-in semester registration form.
3. The self-attested hard copies of all the documents, as per the enclosed checklist & undertaking, is required to be submitted by the students on the day of physical reporting at the Institute to the concerned Registration Incharge.
