SCHOLARSHIP NOTICE

It is for information of all students that the date of inviting Applications (Fresh and Renewal both) under various scholarship schemes of Central Government/State (Assam, Arunachal Pradesh, Bihar, Chandigarh, Dadra & Nagar Haveli, Jammu Kashmir, Manipur, Meghalaya, Karnataka, Himachal Pradesh, Tripura & Uttarakhand) on National Scholarship Portal (www.scholarships.gov.in) for the financial year 2020-21 has been re-activated from 16th August, 2020.

All the eligible students are advised to apply online as per guidelines/eligibility criteria given on the portals and adhere to the timeline for applying. The applicants are advised to follow the following process for applying online:

1. Create User Name on the portal (if applying fresh).

2. Apply on the portal and upload the desired documents (must be scanned from original ones).

3. Valid Income Certificate must be issued in the name of parents only by the competent authority as prescribed by scholarship providing agency/ministries.

4. The Bank Account must be in the name of students. Jan Dhan Account is not acceptable.

- 5. The students are advised to download the **Bonafide Student Certificate** from their online application form and after affixing the recent photograph at the appropriate place, will forwarded/send scanned copy of the same through email to Dean (Student Welfare) at dsw@nith.ac.in for issuing of Bonafide certificate.
- 6. The print-out of application alongwith self attested documents in support of details filled in the online application, must be submitted in the office of the undersigned immediately after submission of online application, failing which the application will not be verified online by Institute.

7. The applicants must check their status frequently to remove the objections raised by verifiers, if any.

Further, it is brought to the notice of all beneficiaries of scholarship schemes that under Section 7 of the Aadhaar (Targeted Delivery of Financial and Other Subsidies, Benefits and Services) Act, 2016, **Aadhar is required**. All the students who have not yet got their Aadhar, are advised to enrol themselves at the nearest enrolment centre available in their local areas at the earliest. Aadhaar notification is applicable in all the states and UTs except the states of Assam, Meghalaya and Jammu & Kashmir.

All the students are advised to check the Institute Website/other scholarship websites & Notice Boards of prominent places regularly for Notices issued by this office from time to time regarding scholarships & other student welfare matters.
