 - o 50% seats for Project Affected Family (PAF) students
 - 25% seats for Project Affected Area (PAA) students which will also include PAF students on merit basis.
 - o 25% seats for Project Affected District (PAD) students which will also include PAF and PAA Students respectively on merit basis.

SJVN SILVER JUBILEE MERITSCHOLARSHIPSCHEME FOR MERITORIOUS STUDENTS

1. Introduction

SJVN Ltd., a Mini Ratna and Schedule 'A' Central Public Sector Undertaking under the Ministry of Power, Govt. of India, is a joint venture between Government of India and Government of Himachal Pradesh. The company has adopted its Corporate Social Responsibility (CSR) Policy to make meaningful contribution towards sustainable socio- economic development of communities through various programs. In this endeavour SJVN has introduced "SJVNMERITSCHOLARSHIPSCHEME FOR MERITORIOUS STUDENTS" which aims at inculcating competitive spirit amongst students and to nurture their academic talent.

2. Eligibility for the scheme

eked of

- (i) The students who have secured minimum 60% or its equivalent grade in 12th class examination in any discipline from a school under State Education Board, CBSE or ICSE in the immediate preceding academic session in the States of Himachal Pradesh, Uttarakhand and Bihar.
- (ii) There will be no domicile restriction for the students for eligibility for the scheme.
- (iii) Recipients of any other scholarship will not be eligible for getting this SJVN scholarship.
- (iv) 100 students will be awarded scholarship of Rs.2000/- (Rs. Two Thousand only) per month for pursuing regular course for the whole duration of next higher course after class 12th like Bachelor's degree in Engineering, Medical, Arts/ Science/ Commerce/ Agriculture/ Horticulture/ Veterinary/ Business Administration/ Computer courses, Law, Cost Accounting Management etc.



(v) The allocation of scholarship will be as per following:

- (i). In the state of Himachal Pradesh, 10% seats will be earmarked for the Project Affected Family (PAF) students and the vacant seats if any will be transferred to the state. Whereas in the states of Bihar and Uttrakhand, the allocated seats will be open only for the project affected district in the following manner:
 - a. 50 % for Project Affected Family (PAF) students.
 - b. 25% for Project Affected Area (PAA) students which will also include PAF students on merit basis.
 - c. 25% for Project affected district students which will also include PAF and PAA students respectively on merit basis.

The vacant seat in any group will be transferred to other group in the order of a to c.

- (ii)The lists of Project Affected District(s), PAA villages, Project affected villages and Project affected family (PAF) will be provided by the respective projects to the implementing agency.
- 3. How to apply
- (i) The Application form can be downloaded from SJVN web site or from the outsourced agency's website or can be obtained from other sources as notified in newspapers.
- (ii) The filled in application should be accompanied with photograph of the student and mark sheet of Class 12th examination.
- (iii) The duly filled in application should be attested by the Principal of the school/institute from which the student is pursuing higher course after passing 12th class.

(iv) The filled-in application must be submitted/sent to the agency by SJVN. No application will be accepted after the last date under any circumstances.

4. Selection Procedure:

Duly filled application forms will be screened by agency engaged by SJVN. The committee/agency will shortlist the candidates on following criteria:

- (i) Rank obtained by the student in terms of marks/ equivalent grade obtained in 10+2 Board Examination.
- (ii) In case of tie of the ranking, the candidate of higher age will be preferred.
- (iii) The shortlisted candidates will be called for the screening with all original academic certificates and testimonials. Mere submission of the application will not guarantee the eligibility for the scholarship.
- (iv) SJVN will have the right to accept or reject the candidature of any candidate at any stage without assigning reasons.
- (v) If sufficient applications are not received in a particular board/ category then the vacant seats can be filled by other boards with the approval of Chairman SJVN Foundation.

5. Release of Scholarship

The scholarship will be provided annually subject to passing of previous year/session examination successfully. The scholarship will be discontinued for the succeeding year/session if a student fails to pass the examination or passes the examination through supplementary examination. The student will be required to submit prescribed requisition form for scholarship for release of the scholarship. The first instalment of scholarship to the students will be provided on some special occasion like SJVN Raising day, Republic day, Teachers' day etc.

6. Definition of Project Affected Area

Project Affected Area means declaration by the Appropriate Government an area of villages or locality under a project for which the land is being acquired under Land Acquisition Act, 1894 or any other Act in force or an area that comes under submergence due to impounding of water in the reservoir of the project or area situated over the underground component of the project. It also includes area as notified by project authority. The unit for measuring project affected area shall be Panchayat.
