i. For all Departments (except Department of Architecture):

- Ph.D Degree in relevant field or equivalent discipline and shall have first class in the preceding degree(s)
(Derived from Schedule-E of NIT Statutes for entry level post).

ii. For Department of Architecture:

- Ph.D Degree in relevant field or equivalent discipline and shall have first class in the preceding degree(s).

Note: If suitable Ph.D. Candidates are not available for Department of Architecture then candidates having M. Arch./ M Plan degree with first class both at PG & UG (B. Arch /B. Plan) and one year professional experience (derived from Schedule-E of NIT Statutes for entry level post) may also be considered.

Note:

- In case first class is not mentioned in the preceding degrees/ certificate/marks sheets, then the candidates should have passed and secured at least 6.5 CGPA (on a 10-point scale) or 60% marks in aggregate.
- Conversion from CGPA to percentage or vice-versa given by individual Institute / University will not be considered /allowed for determination of eligibility.
- In case the candidate has passed and secured CGPA under any other point scale (other than 10 point scale) then certificate issued by the authorized signatory (not the Mentor/ Supervisor/Head of the Department) of the Institute /University to the effect of having secured first class must be attached. Alternately, the CGPA may be equivalently converted on 10 point scale for determination of eligibility.
