Bidder would be required to register in the web-site which is free of cost. For submission of bids, the bidder is required to have digital Signature certificate (DSC) from one of the authorized certifying authorities (CA).

date of opening of financial bid of technically qualified bidders will be published /upload on net.

5. Tender Details:-The tender Documents shall be uploaded in 2 cover:-


Cover 1:-Shall contain scanned copies of all "Technical Documents/Eligibility information".

Cover 2:-Shall contain "BOQ/Financial Bid", where contractor will quote his offer for each item.

6. Submission of Original Documents: The bidders are required to submit (a) original bid security/Earnest Money deposit (EMD) and other technical documents in the O/o Executive Engineer, NIT, Hamirpur as specified in the key dates at **Sr. No.4** above on tender opening dates & schedule, failing which the bids will be declared non-responsive. **EMD in the form of FDR must be pledged in the favour of Registrar, NIT Hamirpur-177005. The EMD should remain valid for a period of 180 / 365 days which ever applicable beyond the final bid validity period i.e. 90 days.** EMD of unsuccessful bidders will be returned after the expiry of the final bid validity or before the 30<sup>th</sup> day of the award of contract. The above condition is applicable to all & no relaxation will be given.
7. BID OPENING DETAIL:- The bids shall be opened as per schedule specified in the key dates of **Sr. No. 4** in the Office of Executive Engineer, NIT, Hamirpur in presence of Tender Opening Committee. The bidders are advised to present along with original documents at the time of opening of tenders in their interest. If the office happens to be closed on the date of opening of the bids as specified, the bids will be opened on the next working day at the same time & venue.
8. The bids for the work shall remain valid for acceptance for a period of not less than 90 days after the deadline i.e. within three months. Other details can be seen in the bidding documents. The officer inviting tender shall not be held liable for any delays due to system failure beyond its control. Even though the system will attempt notify the bidder of any bid updates. The Employer shall not be liable for any information not received by the bidder. It is the bidders responsibility to verify the website for the latest information related to the tender.
9. The copy of enlistment & renewals, Copy of PAN issued by Income tax Department and copy of GST registration Certificate must accompany in the cover-1.
10. The bidder must have successfully completed at least one similar work of value not less than estimated Cost of this work or two similar works each of value not less than 50% estimated cost of this work or three similar works each of value not less than one third of the estimated cost of this work.
11. Rates:- Rates of items may be quoted as per BOQ including GST in Indian currency. Tender will be awarded to the participating bidder who will be lowest in terms of total of all items and as per comparative statement.
12. The tenderer must have valid Electrical License issued by the Chief Electrical Inspector Shimla.
13. The successful tenderer shall be required to submit a Performance Guarantee @3% (Three Percent) of the awarded amount within 15 days after signing the agreement.
14. The bidders shall have to produce supporting documents giving date of award, date of commencement and completion from the concerned competent authority (Rank not less than Executive Engineer) and should be included in cover-1.
15. The financial Bid of those Bidders will only be opened whose technical bid will be approved by the Tender Opening Committee constituted for the purpose.
16. Conditional/ telegraphic tenders shall summarily be rejected.



17. The tender/bid shall be kept in a sealed envelope super scribed as "Tender for (Name of work and date of opening\_\_\_\_\_".
18. Undersigned reserves the right to **accept or reject** the tender of firms having more than two such works pending & whose performance is not satisfactory as per schedule.
19. The jurisdiction of the law of Court shall be at Hamirpur (HP).
20. The rates should be inclusive of all service charges including Building Cess, Water Charges & GST etc. as per Govt. of India notification and should be quoted both in words & figures .


