
The bidders are required to submit

- (i) Original demand draft towards the cost of bid document and
- (ii) Original bid security/Earnest Money deposit (EMD) and other technical documents in the Store & Purchase Section, NIT Hamirpur as specified in the key dates
- (iii) EMD in the form of DD/FDR/Banker Cheque /Bank Guarantee must be attached in favour of Director, NIT, Hamirpur (H.P) -177 005.
- (iv) EMD should be remained valid for a period of 180 days beyond the final bid validity period.
- (v) EMD of unsuccessful bidders shall be returned after the expiry of the final bid validity or before the 30th day of the award of contract.
- (vi) EMD of the successful bidder shall be released after receipt of a performance security for the warranty/guarantee period of equivalent amount.

All the conditions mentioned in the tender notice will be applicable to all & no relaxation will be given.

4. **BID OPENING DETAIL:** - The bids shall be opened in the Store & Purchase Section, NIT Hamirpur by the authorized officer as per schedule specified in the key dates of **Sr. no.5..** In their interest the tenderer are advised to be present along with original documents at the time of opening of tenders. If the office happens to be closed on the date of opening of the bids as specified, the bids will be opened on the next working day at the same time & venue.
5. The bids for the work shall remain valid for acceptance for a period of not less than 90 days after the deadline date for bid submission. Other details can be seen in the bidding documents. 



TERMS AND CONDITIONS:-

1. **Validity:** Minimum validity of the quotation will be 03 months from the date of opening of the quotation/tenders.

2. **Time Limit:** - The firm/supplier has to supply and install the equipments within 30 days from the date of the award letter.
3. **Scope of Work:-** The work includes the following.
 1. The bidder shall supply, install & configure the SSL certificate on Server(s) at National Institute of Technology Hamirpur (HP).
 2. The above mentioned certificate should get installed by the bidder on our existing application server(s) platform.
 3. The Wild Card SSL is required for a validity period of 03 years from the date of issue of the Certificate.
 4. The bidder shall integrate the above mentioned components with all the existing as well as new & upcoming modules and successfully implement the complete solution at NITH Servers in consultation with the concerned teams.
 5. Technical support, Installation, upgrades, updates and applying patches should be provided during support period without any additional cost. The support should include fixes, patch upgrades and any other appropriate correction required for the SSL to be always on the latest available version.
 6. For the installation, testing and post installation support activities the bidder should coordinate with Computer Centre team of the National Institute of Technology Hamirpur (HP).
 7. The SSL certificate will be applicable for 01 main domain i.e. nith.ac.in & sub-domains (*.nith.ac.in). Provision should be made to add any number of sub domain in future without any additional cost.
 8. The bidder shall be responsible for successful implementation of the complete solution on Server(s) of the NIT Hamirpur (HP) in consultation with the concerned teams including its integration and testing with primary domain of NIT Hamirpur and all its sub domain. The bidder shall provide the training on technicalities of integration and deployment along with technical documentation in respect of the same to the satisfaction of the buyer.
 9. Following are the essential features are to be supported by Wild Card SSL certificate to be issued to NIT Hamirpur:-
 - ✓ Latest version
 - ✓ Site visitors should see a padlock icon in the browser and validated organization details in the SSL certificate.
 - ✓ Site visitors should see the Green Address Bar in the SSL certificate.
 - ✓ Supports Web Browser-to-Server(s) and Server(s)-to-Server(s) connections and authentications.
 - ✓ Unlimited free re-issuance of certificate during lifetime validity of SSL. Reissuance shall be required due to minor errors which may occur during the deployment of SSL Certificates or during post-implementation phase as specified under Support-Period Clause.
 - ✓ Expiry notifications.
 - ✓ Should support primary domain e.g. nith.ac.in & all the sub domains under it.
 - ✓ Wild Card SSL Certificate shall be Trusted and Supported by 99% of all the versions of all the Web Browsers viz. Google Chrome, Mozilla Firefox, Opera/Safari, Microsoft Edge, Netscape and Internet Explorer.
 - ✓ It should secure all the sub-domains belonging to nith.ac.in.
 10. **Post Implementation Support (During lifetime of SSL Validity):**
 System Maintenance & Support services will include the following activities:-
 - ✓ Any Problems/Issues/Defects in the issued Certificate, the bidder should be liable to replace the same without any additional cost to NITH.
 - ✓ Technical / User support to NITH Technical team for using Certificate
 - ✓ Free webmail support.
 - ✓ Installation and usage help any problems / issues faced during the generation / installation of the certificates should be taken care of. Also, the vendor should incorporate any changes, in the issuance of the SSL certificate as guided by CCA during the validity period.

4. **Guarantee/warranty:** - The supplier has to provide equipment guarantee/warranty supplied for next 01 year from the date of successful installation of the equipment supplied. (Certificate of the same to be given by the supplier)
5. **Demonstration & Training:-** The supplier will have to demonstrate and impart training to concerned users at NIT, Hamirpur after successful supply & installation. (Certificate of the same to be given by the concerned user/indenter).
6. **EMD: EMD in the form of DD/FDR /Bank Guarantee must be attached in favour of Registrar, NIT, Hamirpur (H.P) -177 005.** The EMD should be remained valid for a period of 60 day beyond the final bid validity period. EMD of unsuccessful bidders shall be returned after the expiry of the final bid validity or before the 30th day of the award of contract. The EMD of the successful bidder shall be released after receipt of a performance security for the warranty/guarantee period of equivalent amount. The above condition is applicable to all & no relaxation will be given.
7. **Destination:** F.O.R. destination i.e. NIT, Hamirpur (HP) and the rates must be quoted inclusive of all taxes and charges.
8. **Price/Rate:** The price of equipment/items may be quoted as per BOQ inclusive of all taxes in Indian rupees dully mentioning the rate of GST separately. In case GST is not mentioned, the rates shall be treated as inclusive of all taxes.
9. **GST/PAN/Nos. etc.** All the firms may invariably mention their GST/PAN numbers on quotation/tender failing which quotations may not be considered valid. Further, this Institution does not issue any C/D Concessional form, so the GST applicable as per actual rates must be mentioned in the offer.
10. **NIT/NIQ Opening:** Representative of the firm may be present at the time of opening of the Quotations, if it wishes.
11. **Payment:** 100% payment shall be made immediately after receipt of material in good condition and successful installation of the same.(Certificate of the same to be given by the indenter/inspection committee NIT, Hamirpur)
12. **Right of Acceptance/Rejection:** Right of acceptance and rejection of any tender/quotation in part or full without assigning any reason are reserved with the institution authorities. The number of items to be purchased could be increased or decreased depending on the requirement of end user.
