Availability of bid document and mode of submission:-The bid document is available online and bid should be submitted in online mode on website http://www.eprocure.gov.in/ and http://www.nith.ac.in/. Bidder would be required to register in the web-site which is free of cost. For submission of bids, the bidder is required to have digital Signature certificate (DSC) from one of the authorized certifying authorities (CA).

- (II) Objections/representation if any against the bidders will be entertained only within three days after publication/uploading of technical bid opening summary on net and there after that the date of opening of financial bid of technically qualified bidders will be published /upload on net.
- 5. Tender Details: The tender Documents shall be uploaded in 2 cover:-

Cover 1:-Shall contain scanned copies of all "Technical Documents/Eligibility information".

Cover 2:-Shall contain "BOQ/Financial Bid", where contractor will quote his offer for each item.

6. Submission of Original Documents: The bidders are required to submit (a) original bid security/Earnest Money deposit (EMD) and other technical documents in the O/o Executive Engineer, NIT, Hamirpur as specified in the key dates of Sr. No.4 on tender opening dates & schedule, failing which the bids will be declared non-responsive. EMD in the form of FDR must be pledged in favour of the Director, NIT Hamirpur-177005. The EMD should be remained valid for a period of 180 days beyond the final bid validity period. EMD of unsuccessful bidders shall be returned after the expiry of the final bid validity or before the 30th day of the award of contract. The above condition is applicable to all & no relaxation will be given.

- 7. BID OPENING DETAIL:- The bids shall be opened as per schedule specified in the key dates of Sr. No. 4 in the Office of Executive Engineer, NIT, Hamirpur by the authorized Tender Opening Committee. In their interest the tenderer are advised to be present along with original documents at the time of opening of tenders. If the office happens to be closed on the date of opening of the bids as specified, the bids will be opened on the next working day at the same time & venue.
- 8. The bids for the work shall remain valid for acceptance for a period of not less than 90 days after the deadline i.e. within three months. Other details can be seen in the bidding documents. The officer inviting tender shall not be held liable for any delays due to system failure beyond its control. Even though the system will attempt notify the bidder of any bid updates. The Employer shall not be liable for any information not received by the bidder. It is the bidders responsibility to verify the website for the latest information related to the tender.
- 9. The copy of enlistment order & renewals, Copy of PAN issued by Income tax Department and copy of GST registration Certificate must accompany in the cover-1.
- 10. The bidder must have successfully completed at least one similar work of value not less than estimated cost of this work or two similar works each of value not less than half the estimated cost of this work or three similar works each of value not less than one third of the estimated cost of this work.
- 11. In case of Electrical Contractors they must possess required valid Electric License from Chief Electrical Inspector and should fulfill the required work experience as per terms and condition.
- 12. The contractors shall have to produce supporting documents giving date of award, date of commencement and completion from the concerned competent authority (Rank not less than Executive Engineer) and should be included in cover-1.
- 13. The financial Bid of those Bidders will only be opened whose technical bid will be approved by the Tender Committee constituted for the purpose.
- 14. Conditional/telegraphic tenders shall summarily be rejected.
- 15. The tender/bid shall be kept in a sealed envelope super scribed as "Tender for (Name of work and date of opening\_\_\_\_\_\_".
- 16. Undersigned reserves the right to accept or reject tender of Firms having more than two such works in hand & whose performance is not satisfactory.
- 17. The jurisdiction of the law of court shall be at Hamirpur (HP).
- 18. The rates should be inclusive of all service charges GST etc. as per Govt. of India notification will be implemented.
- 19. Supplying & installation of UPS lead acid batteries (ESC 120-12 FR) 12 volts 120 AH Under Buy Back offer viz replacement of UPS old lead acid batteries type (ESC 120-12 FR) 12 volts 120 AH capacity complete, after detecting the cost of old batteries including cost of defective leads, burent thimbles if any.
