Regarding Cancellation of award of work dated 11/10/2019 for providing Security Services at NIT Hamirpur against e-tender ID No. 2019_NITH_487660_2 dated 14/08/2019.

This refers to the request received through email dated 27/11/2019 in response to the award letter No. NIT/HMR/Admin/145-Security/2019/12046-54 dated 01/11/2019 for further extension again for a period of atleast two months to complete requisite codal formalities and start from February.

In this context, it is intimated that your aforementioned request for further extension was considered and rejected owing to following reasons.-

Whereas as per B.7 clause of tender document you were required to execute the Contract Agreement along with Performance Bank Guarantee (PBG) amounting to INR 30.00 Lakhs only, accepting all terms and conditions of tender document stipulated therein on a non-judicial stamp paper worth Rs 100/- (Rupees One Hundred only) within fifteen days from the date of issuance of the Letter of Acceptance of BID.

And whereas till date you have neither executed the Contract Agreement nor deposited the Performance Bank Guarantee (PBG) amounting to Rs 30, 00,000/-(Rupees Thirty lakhs only) within the stipulated period as per tender document.

Therefore, your EMD amounting to Rs. 1, 20,000/- (Rupees One lakh twenty thousand only) is hereby forfeited and further you are debarred from participating in any future tender process of NIT Hamirpur (HP).
